# **PRACTICAL INFORMATION**

# **1. ACCREDITATION**

Media access to the Press Centre or to any other place where European Council activities take place with media coverage will be granted only to duly accredited persons. Official accreditation and personal identity documents must be carried at all times.

Accreditation badges are strictly personal and must be worn visibly during the European Council meeting. They give access only to the Press Centre (yellow zone of the building). The Security Centre (tel. +32 (0)2 285 78 51) must be notified immediately of any loss.

Accreditation badges may be collected from the Residence Palace, 155, rue de la Loi, Brussels:

- Friday 18 March 2005 (09.30-13.00 and 14.00-17.00)
- Monday 21 March 2005 (09.30-13.00 and 14.00-19.00)
- Tuesday 22 March 2005 (09.00-20.00)
- Wednesday 23 March 2005 (08.30-17.00)

The last-minute accreditation desk will <u>close at 17.00 on Wednesday 23 March</u> <u>2005</u> even if the European Council meeting is extended.

The identification badge for the summit will be issued only on presentation of both:

- the identity document

- the press card or ORIGINAL letter from the newspaper's editorial office signed by the editor-in-chief stating the professional status of those persons who do not have a press card.

# LATE ACCREDITATION – SPECIAL COUNTER

Journalists who have not applied for accreditation by the deadline (13.00 on 14 March 2005) may apply on-line via the Council's website for late accreditation and go to the accreditation office (see above) **from 18 March 2005** onwards.

The following conditions will apply:

- A. Journalists and technicians already accredited to the European institutions:
  - (1) Commission press card
  - (2) Identity document
- B. Other cases:
  - (1) Valid national identity document, or passport, for EU nationals; passport for non-EU nationals;
  - (2) Valid press card or an ORIGINAL letter dated less than 7 days before the meeting and signed by the editor-in-chief/producer stating the professional status of the media representative (see model attached to the information note on the procedure for late accreditation http://ue.eu.int/eucouncil/lu/late accreditation)

# We regret that, for security reasons, journalists not in possession of these documents cannot be accredited.

Journalists seeking late accreditation **must be prepared to wait**, in order to allow for full verification of the documents presented.

## 2. SECURITY CORDON AROUND THE JUSTUS LIPSIUS BUILDING

The Belgian federal police will establish a security cordon around the Justus Lipsius building (see website **www.polbru.be**) and will refuse access to anyone arriving without an accreditation badge and identity document.

The security cordon will be set up on 22 of March at 15.30 and will remain in place for the entire duration of the European Council meeting.

To allow movement in and out of the security cordon, checkpoints will be set up at the following access points:

Vehicles and pedestrians:

- Rue Archimède/Rond-Point Schuman
- Avenue d'Auderghem/Rond-Point Schuman

Pedestrians only:

- Avenue d'Auderghem/Rond-Point Schuman
- Rue Archimède/Rond-Point Schuman
- Avenue de Cortenbergh/Rond-Point Schuman
- Rue de la Loi at the entrances to Schuman metro station at Résidence Palace
- and Boulevard Charlemagne
- Rue Froissart / Rue Belliard

The security cordon will be lifted when the European Council ends and all Heads of State/Government have left.

#### Access to the building and to the Press Centre

Access will be via the main entrance, rue de la Loi, 175, on presentation of accreditation badge and proof of identity. Everyone entering the building by this route will be obliged to undergo a security check. Access will be refused to anyone arriving without the appropriate identification.

Access to the Press Centre will be granted only on presentation of the accreditation badge for the named individual.

## **Parking**

In no circumstances will journalists be able to park their vehicles inside the security cordon (except for satellite vehicles).

#### Passes for satellite vehicles

Passes for satellite vehicles giving access to the reserved parking spaces within the security cordon, in front of the Justus Lipsius building, will be issued by the Council's Press Office.

# 3. PRESS CENTRE

In addition to the usual press areas, the Press Centre will be installed on levels 20 and 35 of the Justus Lipsius building.

Levels 20 and 35 can be reached by two lifts D accessible via <u>level 00</u>, or by the staircase from level 00 next to the Press Bar (please follow the signs, see attached plans). In addition, a freight elevator (D), located near the Press Bar, level 00, will stop at all floors of the Press Centre (follow arrows for freight elevator).

For security reasons, the Press Centre <u>must</u> close at around 20.00 on Monday 21 March 2005. It will open at <u>07.30</u> on Tuesday 22 March 2005 and will remain open 24 hours a day, if necessary, until the end of the European Council.

The media may deposit technical equipment inside the building on <u>Monday 21 March</u> <u>between 07.00 and 18.00.</u>The equipment will have to be removed on <u>Thursday</u> <u>24 March between 08.00 and 13.00</u> (times to be confirmed in the light of progress of the Council).

# 4. AUDIOVISUAL FACILITIES

The European Broadcasting Union (EBU – UER) provides technical services such as distribution of signals and multilateral and unilateral transmissions, and reservation of editing rooms and positions for presenters.

Television/radio editing rooms are installed mainly on levels 01 and 02 of the Press Centre. The editing rooms on level 35 are located in the interpreters' booths in rooms 35.1, 35.2 and 35.3. These rooms will be allocated when levels 01 and 02 are full in order of receipt of requests. Each room is equipped with a TV, a telephone (analogue line) and an ISDN line, and are able to receive the television signal from the host broadcaster.

Video coverage is provided by the Council's host broadcaster. Europe by Satellite (EbS) also covers the European Council in full, including live coverage of all press conferences held in the main press room. # 5. WRITTEN MEDIA/PRESS AGENCIES

About 1 400 workstations, equipped with telephone and connection for analogue and/or digital modems, and a power supply, are situated as follows:

level 02:  $\pm$  450 workstations level 01:  $\pm$  50 workstations level 00:  $\pm$  300 workstations

On level 00 and 02 it is possible to connect PCs to the Internet using a <u>wireless</u> <u>connection</u> (IEEE 802.11b).

A further 600 places are available for the written press in the 13 briefing rooms on levels 20 and 35 where the main tables are equipped with telephones, modem sockets and a power supply (for access, please refer to point 3 above).

It should be noted that **no PCs are installed** and that workstations in rooms A, B and C (level 00) are not equipped with ISDN lines.

Press agency offices are available on level 02.
